"Belterra Custom Solar-Powered Golf Cart Giveaway"

Official Rules

The **Belterra Custom Solar-Powered Golf Cart Giveaway** ("Giveaway") is sponsored by NATiVE Solar, 201 Cole St., Austin, TX 78737 ("Native"). By entering, each entrant accepts and agrees to be bound by these Official Rules.

This golf cart giveaway is comprised of the following two components: (A) Entering the giveaway by purchasing a solar PV system for a home in Belterra after 5/29/18. The first 20 people who purchase a solar PV system will be automatically entered (one entry) to win and (B) people who have purchased a solar PV system in Belterra after 5/29/18 and are eligible to win via their entry (as described above in (A)) are also eligible to have a second entry to win the golf cart by providing a referral who also lives in Belterra and also purchases a solar PV system from NATiVE Solar. The MINIMUM number of entries will be twenty (20) and the MAXIMUM number of entries will be thirty nine (39). (www.buildnative.com/belterra).

- **1. GIVE-AWAY PERIOD :** The Give-away officially begins at 8:00 am US Central Standard time on May 29, 2018. The give-away period does not have an ending date, but rather a goal of having 20 families purchase a solar PV system for their homes. Once the 20th system is sold the contest officially ends and we will proceed with the random drawing to select a winner.
- 2. **ELIGIBILITY:** Participation in the Giveaway is open only to legal residents Belterra (must own a residence in Belterra) and who are 21 years of age or older on the date of the Give-away entry submission. NATiVE Solar employees and any of its affiliates, subsidiaries, agents, distributors/wholesalers, retailers and their advertising and promotional agencies as well as the spouse, parents, siblings and children and household



members of each such employee, are not eligible. VOID OUTSIDE THE specific neighborhood of Belterra in Hays County, Texas.

- 3. AGREEMENT TO OFFICIAL RULES: Your participation in the Give-away constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of NATiVE Solar, which are final and binding on all matters related to the Give-away. Upon purchasing a solar PV system from NATiVE Solar, you will automatically be entered (with one entry) to win. You can possibly earn a second entry to win by being a person who has already purchased a solar PV system in Belterra after 5/29/18 (and is eligible to win via their entry (as described above)) by providing a referral who also lives in Belterra and also purchases a solar PV system from NATiVE Solar. The MINIMUM number of entries will be twenty (20) and the MAXIMUM number of entries will be thirty nine (39).
- 5. **RANDOM GIVEAWAY DRAWING:** The MINIMUM number of entries will be twenty (20) and the MAXIMUM number of entries will be thirty nine (39). NATiVE Solar will conduct a random drawing within five (5) business days immediately following the sale of the 20th solar system in Belterra. Odds of winning depend upon the number of eligible entries received (will be between 20 and 39 total entries). A purchase of NATiVE Solar's products is required and winners must meet all eligibility requirements including the execution and installation of a solar PV system at their Belterra home. All potential Giveaway entries are subject to verification by NATiVE Solar, whose decision is final and binding in all matters related to the Give-away. The random drawing will be held at a give-away EVENT that will be well-publicized in Belterra and each person with a valid entry will be notified via email and phone call and in person (if possible). The winner does not need to be present at this event to win – there will only be ONE DRAWING and that person wins the golf cart. Native will deliver the cart to



the winner. Winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Winner is responsible for all applicable taxes, licensing and registration fees associated with Prize.

PRIZES: One (1) entry will be drawn randomly to receive a Grand Prize Onward ®, valued at approximately \$12,000.00 (twelve thousand dollars). Prizes are non transferable until awarded, non-refundable, and must be accepted as awarded. No cash or other substitution may be made except by NATiVE Solar, who reserves the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason as determined by NATiVE Solar in NATiVE Solar's sole discretion. Winners are responsible for all applicable taxes associated with receipt of a prize. NATiVE Solar will report any individual winnings over \$600 (in cash or fair market value of goods or services) in a one-year period to the Internal Revenue Service. Winners will receive a Form 1099 from NATiVE Solar if NATiVE Solar reports any winnings to the Internal Revenue Service.

During the Give-away the following prizes will be awarded:

A custom solar-powered golf cart.

NATiVE Solar will be responsible for transport costs of delivering the prize to the winner's residence.

GENERAL CONDITIONS: NATiVE Solar reserves the right to cancel, suspend, and/or modify the Give-away if any fraud, virus or other technical problem corrupts the administration, security, validity, or proper play, as determined by NATiVE Solar in NATiVE Solar's sole discretion. In such event, NATiVE Solar reserves the right to award the prize at random from among the eligible entries received up to the time of the impairment. NATiVE Solar reserves the right in NATiVE Solar's sole discretion to disqualify any individual who does not follow through with the solar system purchase and



installation or to be acting in violation of these Official Rules. Any attempt by any person to undermine the legitimate operation of the Give-away may be a violation of criminal and civil law, and, should such an attempt be made, NATiVE Solar reserves the right to seek damages from any such person to the fullest extent permitted by law. NATiVE Solar's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- **7. PUBLICITY**: Except where prohibited, participation in the Give-away constitutes winner's consent to NATiVE Solar's use of winner's name, likeness, images, voice, opinions, biographical information and state of residence for promotional purposes in any media worldwide without further payment or consideration.
- **8. PRIVACY**: All information submitted by you as part of the Giveaway will be treated in strict confidentiality.
